Cryosphere Action Plan: Co-published with the World Bank as the "On Thin Ice" report, the Cryosphere Action Plan comprised the greatest ICCI focus throughout 2013, involving over 100 scientists, policy makers and reviewers working in all major cryosphere regions. This work culminated at the annual climate negotiations under the UN Framework Convention on Climate Change (UNFCCC) in Warsaw, COP-19, with a "Cryosphere Day" on November 17, 2013. The Day brought together a cross-section of cryosphere scientists and policy makers, all live-streamed for a global audience on the ICCI website. The Report gained extensive media attention and is now considered the "gold standard" for both short-lived pollutant impacts, and the "State of the Cryosphere" in 2013.

Arctic Impacts from Agricultural Burning: ICCI conducted on-the-ground pilot projects to decrease black carbon emissions from agricultural field and forest burning, working with farmers in three oblasts in Russia. This work is highly relevant not only for climate change, but future food security and rural development. ICCI also gained Climate and Clean Air Coalition support for a new project to do the same in the Himalayas and Andes.

Decreasing Black Carbon Pollution from Woodburning: ICCI worked with governments, producers and consumers under the Nordic Council to decrease emissions from woodstoves, in work that ultimately could impact standards throughout Europe. This included development of consumer burning guidance pamphlets in three languages that will be distributed by stove producers and local municipalities, a tabletop study of past regulations' effectiveness in Nordic countries, and work on a specific testing protocol for black carbon emissions.
