Reducing Open Burning in the Eastern Himalayas and Andes: Partners: UNEP/Climate and Clean Air Coalition, Molina Center for Energy and the Environment (MCE2), ICIMOD (Kathmandu, Nepal), CONDESAN and ANA (Lima, Peru) and other local community-based organizations. Phase 1 of this three-part CCAC project in 2014 involved mapping of open burning patterns in these two important cryosphere regions. 2015 saw development of regional networks to address this major threat to food security, health and climate; two regional conferences; design of regional demonstration projects; and CCAC approval of a Phase 2 project that will implement some of these demonstration projects and create regional advisory groups to aid in a transition to these more climate- and glacier-friendly policies in 2016.

4b (Code:) (Expenses \$ 60,941. including grants of \$) (Revenue \$)

Cryosphere 2015: a two-year science-policy effort aimed at raising ambitions in the UNFCCC Paris Agreement. ICCI's current and ex-diplomats worked closely with IPCC scientists and other researchers; seminars and other efforts intensified in 2015 and culminated at COP-21 in December. At the June 2015 Bonn negotiations, the concept of certain cryosphere dynamics as "irreversible" was introduced to negotiators and media; Bonn discussions also noted the need for an IPCC Special Report on these cryosphere risks, feeding into the later IPCC favorable decision. Paris saw the release of the "Thresholds Report," which analyzed Paris commitments for long-term global impacts on and from cryosphere. It was widely distributed, including at several ICCI-organized side events and media briefings; and quoted often by leaders and negotiators as underpinning the need for a 1.5 degree goal.

Woodburning in Nordic Countries: Nordic Council of Ministers. Partners: Danish Technology Institute, Sintef (Norway) and SP (Sweden). Project worked with several Nordic testing agencies to further develop a standard means to test black carbon emissions from wood stoves together with Nordic and U.S. experts (Dr. Tami Bond in particular). Work expanded globally late in 2015 as a project with UNEP/the Climate and Clean Air Coalition.

ICCI also continued efforts to raise the profile of Antarctic climate change and the risk of crossing thresholds there, in particular related to instability of West Antarctica.
