Cryosphere 2020/High Urgency:

As part of this ongoing process aimed at the next round of pledges under the Paris Agreement, ICCI conducts Chatham House rules meetings of negotiators and top cryosphere scientists, many of them IPCC authors on the 1.5 Degree Report and Special Report on Oceans and Cryosphere. Discussions focus on how the latest science might be more effectively appreciated, and acted upon. Due to the Covid-19 pandemic, meetings in 2021 were held virtually; but bore fruit when the delayed COP-26 took place in Glasgow. ICCI also continued to host "Cryosphere1.5" briefings via zoom and other online platforms with policy makers and other stakeholders; and conducted communications trainings, designed and conducted by the University of West Anglia for the early career scientists.

Reducing Heating Stove Emissions

ICCI continues its work on reducing short-lived climate forcer air pollution from wood and coal heating stoves, both under the LRTAP Convention, and on the local level in Vermont. The Vermont project engages households directly on using their existing woodstoves more effectively to reduce harmful emissions and wood use (also as sustainable forest management), as well as encourages transition to either low-emissions stoves, or cleaner and renewable sources of energy for household heating.

COP-26 Cryosphere Pavilion:

COP-26 in Glasgow saw the second Cryosphere Pavilion, which built on the COP-25 Pavilion experience. Due to the importance of sufficiently ambitious 2030 NDCs, the COP-26 Pavilion focused on the implications of overshoot in terms of both CO2 emissions and temperature; as well as the path forward to achieve the needed 50% reductions by governments and other stakeholders. It aimed to generate both greater political level and public support for climate action plans consistent with a 1.5°C goal incorporated into 2030 NDCs, specifically to prevent cryosphere collapse and irreversible feedbacks, with 64 seminars (side events), cultural events and a permanent exhibits. It also supported early career scientists to volunteer and interact with policymakers as the next generation of scientific leaders. The single most important outcome of ICCI and Cryosphere Pavilion efforts was the introduction, into the debate around the COP-26 Decision or "Glasgow Pact," of the need for better inclusion of cryosphere concerns: a first in the UNFCCC. An estimated 15,000 visitors passed through the Pavilion over the 12 days of the COP, including heads of government and a number of climate/environment ministers representing cryosphere regions from around the world; all events at the Pavilion were also live-streamed, with recording cached on ICCI's YouTube channel.

Arctic and Antarctica:

ICCI co-chairs Arctic 21, a broad coalition of U.S. NGOs working within the Arctic Council; and also participates in ASOC, an international coalition of Antarctic-related organizations accredited to the Antarctic Consultative Treaty Mechanism (ACTM); and the Clean Arctic Alliance, focused on shipping climate pollution impacts in the Arctic region. ICCI continues to work to bring climate

concerns more specifically into the work of the ATCM, given Antarctica's importance to the global climate system, especially its growing impact on sea-level rise. ICCI also partnered with Umeå University/Abisko Field Station, just above the Arctic Circle in Sweden, to develop an interactive exhibit for visiting international tourists about how global warming is changing the entire character of this High North ecosystem; this may be used as a model for other public exhibits in national park environments.

**Reducing Agricultural Sector Field Burning:**

ICCI continued shepherding a Guidance Document on alternatives to agricultural burning through Convention on Long-range Transboundary Air Pollution (CLRTAP) approval process; the Guidance was approved at the Executive Bureau meeting in Geneva in December 2021. The U.S. Forest Service/USDA approached ICCI in fall 2021 to develop a mapping and groundtruthing project in Ecuador, to build on the successful three-year Peru project focused on alternatives to open burning in regions where glaciers impacted by black carbon provide important water resources. No-burn agriculture will form an important role in both reducing greenhouse gas emissions from burned soil and wildfires that spread from this practice; as well as drawdown of carbon into carbon-poor previously burned soils.
